The work to be performed is the audit of the general purpose financial statements for the twelve months ending September 30, 1999 for the City of Weston, Texas. The audit will be performed in accordance with generally accepted auditing standards and will include an opinion as to whether the financial statements are presented in conformity with generally accepted accounting principles as established by the American Institute of Certified Public Accountants and the Single Audit Act of 1996. A management letter will be provided and shall include a statement of audit findings regarding the financial statements and the system of internal accounting controls.

Upon completion of the field work an exit conference will be held with the City Secretary at which time the proposed report and management letter will be reviewed. We also expect to present the audit to the City Council after its acceptance by the City Secretary.

The maximum fee for the September 30, 1999 audit, as discussed in the FEE PROPOSAL section, is \$2,500.



EXAMINATION APPROACH

One of the strengths of our Firm is that Mr. Spore supervises all of the field work and prepares the financial statement himself. The staff of the City of Weston will work directly with Mr. Spore, no part of the audit will be assigned to less qualified staff. Mr. Spore will also present the financial statements to the City Secretary and the City Council.

All of the field work will be performed at the City's offices. The primary assistance the City's staff will provide during the field work will be in pulling paid invoices, canceled checks, legal documents, etc.

Once the field work is completed the financial statements and the management letter will be prepared. Drafts of the financial statements and the management letter will be reviewed with the City Secretary for approval. All adjusting entries and the final trial balance will be provided to the City Secretary for posting to the City's books and records.

The audit will be performed in accordance with generally accepted auditing standards. If conditions are discovered which lead to the belief that material errors, defalcations, or other irregularities may exist, or if any other circumstances are encountered that require extended services we will promptly advise the City Secretary. No extended services will be performed unless they are authorized by the City of Weston.

In accordance with auditing standards, the Firm will select the necessary procedures to test compliance and to disclose noncompliance with specific laws, regulations and contracts.

FEE PROPOSAL

Our fee for these services will not exceed \$2,500 for September 1999 audit. This estimate is based upon anticipated cooperation from your personnel and the assumption that unexpected circumstances will not be encountered during the audit. If significant additional time is required we will discuss it with you before incurring the additional time.

A down payment of \$1,000 will be due prior to starting the audit with the balance of the fee due upon completion of the audit and delivery of the final reports.
