A RESOLUTION OF THE CITY OF WESTON, TEXAS, COLLIN COUNTY, TEXAS, CERTIFYING THE ELECTION RESULTS FOR THE GENERAL ELECTION FOR THE CITY OF WESTON, TEXAS HELD IN THE CITY OF WESTON, COLLIN COUNTY, TEXAS, ON NOVEMBER 6, 2018, FOR THE PURPOSE OF ELECTING THREE (3) COUNCIL MEMBERS TO SERVE A TWO (2) YEAR TERM.


