### **ORDINANCE NO. 2015-10-02**

AN ORDINANCE OF THE CITY OF WESTON, TEXAS ADOPTING THE 2015 NORTH (NCTCOG) CENTRAL **TEXAS** COUNCIL OF GOVERNMENTS AMENDMENTS TO THE 2015 INTERNATIONAL BUILDING, EXISTING BUILDING, RESIDENTIAL, FIRE, PLUMBING, MECHANICAL, FUEL GAS, AND ENERGY CONSERVATION CODES AND TO THE 2014 NATIONAL ELECTRICAL CODE: PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES; PROVIDING FOR A PENALTY FOR VIOLATIONS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY AND A SAVINGS CLAUSE; PROVIDING FOR PUBLICATION IN THE OFFICIAL NEWSPAPER: AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Weston, Texas is a Type A general-law municipality located in Collin County, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council of the city of Weston desires to adopt the 2015 NCTCOG Regional Amendments to the 2015 International Building, Existing Building, Residential, Plumbing, Mechanical, Fuel Gas, Energy Conservation, Existing Building, Fire Code, and the 2014 National Electrical Code as the official municipal codes of the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTON, TEXAS

#### **SECTION 1**

#### ADOPTION OF THE NCTCOG 2015 INTERNATIONAL BUILDING CODE REGIONAL AMENDMENTS OPTION B

The 2015 NCTCOG International Building Code Regional Amendments Option B are hereby adopted as the official building code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

#### SECTION 2

### ADOPTION OF THE NCTCOG 2015 INTERNATIONAL EXISTING BUILDING CODE REGIONAL AMENDMENTS

The 2015 NCTCOG International Existing Building Code Regional Amendments are hereby adopted as the official existing building code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

#### **SECTION 3**

### ADOPTION OF 2015 NCTCOG INTERNATIONAL RESIDENTIAL CODE REGIONAL AMENDMENTS OPTION B

The 2015 NCTCOG International Residential Code Regional Amendments Option B are hereby adopted as the official residential construction code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

### **SECTION 4**

# RESOLUTION OF CONFLICTS BETWEEN INTERNATIONAL BUILDING CODE AND INTERNATIONAL RESIDENTIAL CODE

To the extent of any conflict between the 2015 International Building Code or the 2015 International Existing Building Code, as applied to residential property and the 2015 International Residential Code, the 2015 International Residential Code and the 2015 NCTCOG International Residential Code Regional Amendments shall control.

#### **SECTION 5**

#### ADOPTION OF 2015 NCTCOG INTERNATIONAL PLUMBING CODE REGIONAL AMENDMENTS

The 2015 NCTCOG International Plumbing Code Regional Amendments are hereby adopted as the official plumbing code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

#### **SECTION 6**

#### ADOPTION OF 2015 NCTCOG INTERNATIONAL MECHANICAL CODE REGIONAL AMENDMENTS

The 2015 NCTCOG International Mechanical Code Regional Amendments are hereby adopted as the official mechanical code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

# SECTION 7 ADOPTION OF 2015 NCTCOG INTERNATIONAL FUEL GAS CODE REGIONAL AMENDMENTS

The 2015 NCTCOG International Fuel Gas Code Regional Amendments are hereby adopted as the official fuel gas code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

#### **SECTION 8**

### ADOPTION OF 2015 NCTCOG INTERNATIONAL ENERGY CONSERVATION CODE REGIONAL AMENDMENTS

The 2015 NCTCOG International Energy Conservation Code Regional Amendments are hereby adopted as the official energy conservation code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

### SECTION 9 ADOPTION OF 2015 INTERNATIONAL FIRE CODE REGIONAL AMENDMENTS OPTION B

The 2015 NCTCOG International Fire Code Regional Amendments Option B are hereby adopted as the official fire code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

### SECTION 10 ADOPTION OF 2015 NCTCOG REGIONAL AMENDMENTS TO THE 2014 NATIONAL ELECTRICAL CODE

The 2015 NCTCOG Recommended Amendments to the 2014 National Electrical Code are hereby adopted as the official electrical code of the City of Weston, Texas, and are fully incorporated by reference as though copied into this ordinance in its entirety.

# SECTION 11 ADDITIONAL LOCAL AMENDMENTS CONTEMPLATED

The City of Weston may from time to time determine that additional local modifications to the codes adopted herein are necessary and appropriate to meet the unique building needs of the City of Weston. To effectuate modifications, the city council may enact individual ordinances amending this ordinance fully setting forth the change to be made in the specific code. Such subsequent amendments shall be consolidated as an exhibit to this ordinance, and shall be maintained as a public record in the office of the City Secretary.

# SECTION 12 PERMITS AND FEES

The codes adopted herein provide for the issuance of certain permits and the collection of fees therefore. The fees shall be established by the City's schedule of fees.

# SECTION 13 PENALTY

Any person, firm or corporation who violates, disobeys, omits, neglects or refuses to comply with or who resists the enforcement of any of the provisions of this ordinances shall be fined no more than Two Thousand Dollars and no cents (\$2,000.00) for all violations and shall be fined not more than Five Hundred Dollars and no cents (\$500.00) for all other violations of this Ordinance. Each day that a violation is permitted to exist shall constitute a separate offense.

# SECTION 14 PROVISION CUMULATIVE BUT CONFLICTING ORDINANCES REPEALED

This Ordinance shall be cumulative of all provisions of all existing Ordinances of the City of Weston, Texas, as amended, except where the provisions of this ordinance are in direct conflict with the provisions of such existing ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

# SECTION 15 PROVISIONS SEVERABLE

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining, phrase, clauses, sentences, paragraphs or sections of this Ordinance since the same would have been enacted by the City Council without incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

# SECTION 16 PREVIOUSLY ACCRUING RIGHTS AND REMEDIES SAVED

All rights and remedies of the Oity of Weston, Texas, are expressly saved as to any and all violations of the provisions of the Building Code, Residential Code, Electrical Code, Energy Code, Fuel Gas Code, Mechanical Code, Plumbing Code, Existing Building Code, Property Maintenance Code, Fire Code or any other ordinances affecting such codes which have accrued at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances same shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts.

## SECTION 17 PUBLICATION

The City Secretary of the City of Weston is directed to publish the caption and effective date of this Ordinance in accordance with the provisions of Section 52.011 of the Local Government Code.

### SECTION 18 EFFECTIVE DATE

This Ordinance shall be in full force and effect from and after its passage and publication as provided by law, and it is so ordained.
