- b. Briefing regarding the current status and community-facing information related to the Collin County Outer Loop. (Johnston)
 - Briefly discussed that Outer Loop will open all at once, not in phases, on or before April, 2026.
 - Intersection of Custer/Outer Loop
 - o Celina is performing a traffic study to see if a traffic light is warranted.
 - o In the meantime, a 4-way stop will be in place.
 - Intersection of Weston Road/Outer Loop
 - o The Design Consultant is performing a traffic study to see if a traffic light is warranted.
 - In the meantime, a 2-way stop will be in place on the Outer Loop and Weston Road will be free flowing.
 - CR 125
 - o Will no longer connect Weston Road to Custer Road (FM 2478)..
 - There will be a cul-de-sac allowing access to the residents along CR 125 but no thru traffic access.
 - o East bound from Custer will tie into the Outer Loop at CR 168.
- c. Briefing regarding current status on FM 455. (Mayor)
 - Mayor Marchiori provided general comments pertaining to a recent TxDOT/BGE/Weston meeting held on September 29, 2025.
 - TxDOT/BGE presented a map displaying several options that TxDOT/BGE/Collin County has proposed for FM 455 stated Weston needs to provide input utilizing an updated analysis considering new developments, routes, etc. Once Weston has communicated its proposed plan, TxDOT would host a public hearing for all affected parties.
 - It was noted that approximately 7 out of 10 of the options from county utilized Cowan Road.
 - TxDOT made reference to the intent of Collin County to have a mobility plan eventually achieving West/East thoroughfares every 1-2 miles from US 380 to the Northern Collin County

boundary. Underpinning the fact that no matter where TxDOT builds the FM 455 re-route, the County may be building additional thoroughfares North and South of it.

- He also stated the TxDOT Project Timeframe is approximately 8-10 years.
- Weston will plan a public hearing prior to feedback being provided to TxDOT.
