ORDINANCE NO. 2000-09-06

AN ORDINANCE RATIFYING AND REPUBLISHING THE ANNEXATION OF THE HEREINAFTER DESCRIBED 45.30± ACRE TRACT INTO THE CITY OF WESTON, COLLIN COUNTY, TEXAS, GRANTING TO SAID TERRITORY AND TO ALL INHABITANTS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS AND ORDINANCES OF THE CITY OF WESTON; AND PROVIDING FOR AN EFFECTIVE DATE AND FILING INSTRUCTIONS.

WHEREAS, a portion or portions of the territory made the subject of this ordinance were included in, and made a part of, the original incorporation of the City of Weston, Texas, in the year 1971;

WHEREAS, J.W. Carpenter and Dean Thurman, then owners of the territory made the subject of this ordinance, voluntarily petitioned the City of Weston in May of 1983 to annex those portions of said property into the City of Weston not included in, nor made a part of, the original incorporation of the City of Weston in 1971;

WHEREAS, on June 14, 1983, the Weston City Council unanimously approved the annexation of said territory into the City of Weston, being a 45.30± acre tract of land now described as Tracts 4-9, 6, 6-9, 18, 21, 22, 23, 25, 29, 31, 32, and 44, or portions thereof, on the Map of the Collin County Central Appraisal District for the John Cunningham Survey (Abstract 214), Collin County, Texas, as of August, 2000;

WHEREAS, in approving the annexation of said territory into the City of Weston, the Weston City Council granted to said territory and to all inhabitants of said property all of the rights and privileges of other citizens of the City of Weston, and bound said inhabitants by all of the acts and ordinances of the City of Weston henceforth;

WHEREAS, said territory and all inhabitants of said property have enjoyed all of the rights and privileges of other citizens of the City of Weston, having had the right to determine local policy and planning by voting in local elections and having used and benefited from City services since the effective date of annexation into the City of Weston;

WHEREAS, the Texas State Legislature has itself previously validated the annexation of the territory made the subject of this ordinance into the City of Weston, Texas; and

WHEREAS, the Weston City Council desires to ratify, reaffirm, and republish the annexation of said territory into the City of Weston by the adoption of this ordinance, in part to make municipal records and information more available and convenient to the citizens of Weston.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTON, TEXAS:

Section 1. Annexation.

That the following described territory, to-wit:

A 45.30± acre tract of land now described as Tracts 4-9, 6, 6-9, 18, 21, 22, 23, 25, 29, 31, 32, and 44, or portions thereof, on the Map of the Collin County Central Appraisal District for the John Cunningham Survey (Abstract 214), Collin County, Texas, as of August, 2000.

be and the same is hereby annexed into the City of Weston, Collin County, Texas, and that the boundary limits of the City of Weston, Texas, be and the same are hereby extended to include the above-described territory within the city limits of the City of Weston, Texas, and the same shall hereafter be included within the territorial limits of said City and said land and the future inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Weston, Texas, and shall be bound by the acts and ordinances of said City.

Section 2. Service Plan.

The Service Plan attached hereto as Exhibit "A" is hereby adopted and the same shall govern the delivery of Weston's municipal services to the annexed territory.

Section 3. Effective Date.

This Ordinance shall be effective on the date of its adoption.

Section 4. Filing Instructions.

The City Secretary is directed to file a certified copy of this Ordinance with the County Clerk of Collin County, Texas, and with the Collin County Central Appraisal District.
