ORDINANCE NO. <u>2000-02-01</u>

AN ORDINANCE OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS, DISANNEXING CERTAIN TERRITORY FROM THE CORPORATE LIMITS OF THE CITY PURSUANT TO V.T.C.A., LOCAL GOVERNMENT CODE SECTION 43.144; AMENDING THE CORPORATE LIMITS OF THE CITY TO COMPLY WITH THE SAID DISANNEXATION; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, Tracts 7, 7-9, 8, 37, and 37-9 of the Levi Melvin Survey, Abstract No. 598, a copy of which is attached hereto and made a part hereof as Exhibit "A", were incorporated as part of the City of Weston in 1971. The combined territory of the said Tracts is more particularly described by metes and bounds, also included in Exhibit "A";

WHEREAS, said Tracts are contiguous and form a combined territory of at least ten (10) acres of land that contains fewer than one (1) occupied residence or business structure for every two (2) acres and fewer than three (3) occupied residences or businesses on any one (1) acre;

WHEREAS, all property owners of the said Tracts described in Exhibit "A" have requested in writing that these Tracts be disannexed from the City of Weston; and

WHEREAS, the City Council of Weston believes that disannexation of the Tracts described in Exhibit "A" is in the general welfare of the City and the property owners of the said Tracts.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS.

Section 1. Disannexation of Area

Pursuant to V.T.C.A., Local Government Code Section 43.144, Tracts 7, 7-9, 8, 37, and 37-9 of the Levi Melvin Survey, Abstract 598, as described in the attached Exhibit "A", are hereby disannexed from the corporate limits of the City.

Section 2. Corporate Limits Amended

The corporate limits of the City of Weston are hereby amended to comply with the disannexation described in this Ordinance.

Section 3. Authorization

The Mayor of Weston is hereby authorized and directed to implement this Ordinance immediately upon its adoption.

Section 4. Effective Date

This Ordinance shall be effective on the date of its adoption.



Metes and Bounds Description of Disannexed Area

BEING an area of land made up of Tracts 7, 7-9, 8, 37, and 37-9 located in the Levi Melvin Survey, Abstract No. 598, City of Weston, Collin County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING in the West boundary line of the Levi Melvin Survey, Abstract No. 598, at a point in the center line of FM Road 455;

THENCE South along the West boundary line of the Levi Melvin Survey, Abstract No. 598, a distance of approximately 500 feet to a point in the existing City of Weston boundary;

THENCE in an Easterly direction in the Levi Melvin Survey, Abstract No. 598, along the existing City of Weston boundary a distance of approximately 1760 feet to a point in the East boundary line of Tract 37-9;

THENCE in a Northerly direction in the Levi Melvin Survey, Abstract No. 598, along the East boundary of Tract 37-9 a distance of approximately 640 feet to a point in the center line of FM Road 455;

THENCE in a Westerly direction in the Levi Melvin Survey, Abstract No. 598, along the center line of FM Road 455 a distance of approximately 1700 feet to the POINT OF BEGINNING, said area containing 18.617 acres more or less.
