

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WESTON, TEXAS, AUTHORIZING THE MAYOR TO OPEN NEW BANK ACCOUNT(S) WITH EITHER LAMAR NATIONAL BANK AND/OR INDEPENDENCE FINANCIAL; PROVIDING FOR SEVERABILITY; AND DESIGNATING CERTAIN MUNICIPAL POSITIONS AS AUTHORIZED SIGNATORIES FOR ALL FIRE DEPARTMENT ACCOUNT(S); AND ESTABLISH AN EFFECTIVE DATE.

WHEREAS, the Town of Weston, Texas (the "Town"), is a general law municipality located in Collin County, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the Town Council desires to authorize the Mayor to open a new bank account (s) with Lamar National Bank and/or Independent Financial for the Fire Department fund.

WHEREAS, the Town Council desires to designate certain positions as authorized signatories for all Fire Department account(s) maintained by Lamar National Bank and/or Independence Financial.;

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF WESTON, TEXAS:

SECTION 1. The recitals contained in the preamble of this Resolution are determined to be true and correct and are hereby adopted as a part of this Resolution.

SECTION 2. The Town Council hereby authorizes the Mayor to open new account (s) for the Fire Department fund including necessary transfer of funds to new account (s) with Lamar National Bank and/or Independent Financial.

SECTION 3. It is hereby declared that the sections, paragraphs, sentences, clauses, and phrases of this Resolution are severable and, if any phrase, clause, sentence, paragraph, or section of this Resolution shall be declared unconstitutional or invalid by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Resolution, because the same would have been enacted by the Board of Directors without the incorporation of any such unconstitutional phrase, clause, sentence, paragraph, or section.

SECTION 4. That the following representatives are authorized to make transactions on behalf of the Town of Weston Fire Department fund at either Lamar National Bank and/or Independence Financial

- A. Jerry Randall, Mayor
- B. Charles Schneider, Fire Chief
- C. Kristina Dean, Town Secretary

SECTION 5. All resolutions and parts thereof in conflict herewith are hereby expressly repealed insofar as they conflict herewith.

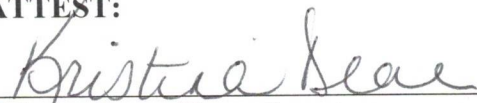
SECTION 6. This Resolution is effective immediately upon its passage.
